**RULES & REGULATIONS:**

- 1: Rules will be interpreted by the director of the event and all decisions are final.
- 2: 15-inch limit on all large mouth / spotted bass (measured on straight board with mouth closed and tail pulled back straight) with five fish limit per boat.
- 3: Short fish penalty applies. Short fish plus biggest fish will be disqualified from weighing.
- 4: We promote "Catch & Release". All fish must be released after weigh-in.
- 5: No dead fish will be weighed!
- 6: No live bait or trolling! (Artificial lures only)
- 7: Live well will be checked at blast off. If not checked at blast off, team will be disqualified at weigh-in.
- 8: Teams must be in "No Wake Zone" at the Winchester City Park (Bass Club) by end of tournament (1:30pm) and fish presented for weigh-in within 15 minutes from the end of tournament. In case of waiting period, notify tournament director of being in weigh-in line or team will be disqualified after fifteen(15) minute grace period.
- 9: Order of departure determined in order registration received.
- 10: At all times, T.W.R.A. rules & regulations will apply while on Tims Ford Lake and waters.
- 11: Subject to polygraph.
- 12: Tournament director determines cancellation due to bad weather conditions.
- 13: Sportsmanship manner applies at all times.

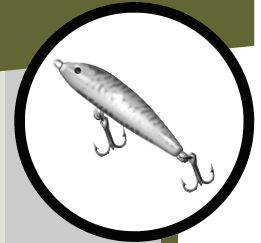

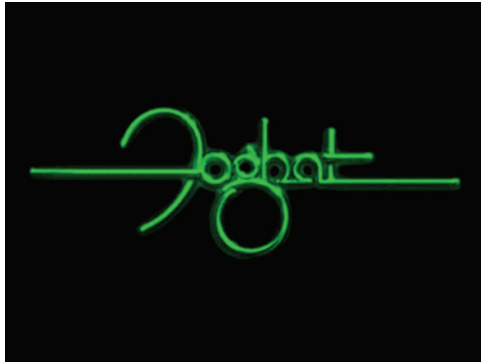

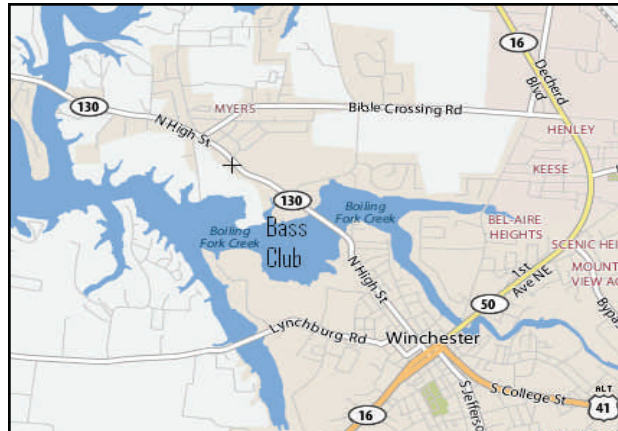
